

## **Tereos successfully completes debt capital markets transaction**

### **Issuance of €300 million Senior Notes due 2031**

Tereos SCA (“Tereos” and together with its subsidiaries, the “Group”) today announces the completion of the offering (the “Offering”) and issuance of the new €300 million 5.750% senior notes due 2031 (the “Notes”), whose pricing was announced on January 8, 2025.

The gross proceeds from the Offering will be used to repay Tereos’ unsecured term loan facility guaranteed by the French State (*Prêt Garanti par l’Etat*) and other indebtedness of the Group on or before the applicable maturity dates, for general corporate purposes, and to pay costs, fees and expenses in connection with the Offering, including the expenses and any accrued and unpaid interest due under the indebtedness to be repaid with the proceeds of the Offering.

The success of this transaction underlines the Group’s strong recent results and the active management of its debt structure.

The strategy implemented by the management team over the last four years has continued to deliver the expected results, contributing to the strong and continuous improvement in profitability. After a series of refinancing operations and rating upgrades from both S&P and Fitch, Tereos has today concluded a fifth successful issuance since 2021, an outcome that demonstrates the investor confidence in the Group’s governance and its strategy during the period.
